SECTION 4: First aid measures

4.1. Description of first aid measures

General information

5.1. Extinguishing media

5.3. Advice for firefighters

6.1. Personal precautions, protective equipment and emergency procedures

6.2. Environmental precautions

Environmental precautions Avoid discharge into drains or watercourses or onto the ground. Not considered to be a significant hazard due to the small quantities used.

6.3. Methods and material for containment and cleaning up

Methods for cleaning up Clear up spills immediately and dispose of waste safely. Eliminate all ignition sources if safe to do so. No smoking, sparks, flames or other sources of ignition near spillage. Under normal conditions of handling and storage, spillages from aerosol containers are unlikely. If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurised contents and propellant. Provide adequate ventilation. Do not expose to temperatures exceeding 50°C/122°F. Avoid inhalation of vapours and spray/mists. Avoid contact with eyes.
