

# **PlastiKote Leaf Paint**

## **Technical Information**

Leaf is available in Silver and Gold. This can be used as an under-layer paint or as an accent. By spraying before applying the matt Chalk paint, when dry, the top layer of Chalk can be wiped back with a domestic pot scourer to reveal the Leaf below. This give an authentic aged look when wiped back from edges and mouldings where an antique piece of furniture might have worn.

- Quick drying
- The product can also be used underneath PlastiKote Chalk Sprays to create a classic looking piece of furniture

- Surfaces: metal, glass, ceramics, stone, wood, paper, carton and many other surfaces
  - Minimum Working Temperature: 15 °C
- Maximum Working Temperature: 25 °C

### How to use

- Before use, carefully read the directions on the packaging and act accordingly.
- The surface should be clean, dry and free of grease. Remove loose old lacquer and rust and sand the surface.
- The surface should be clean, dry and free of grease. The aerosol should have room temperature. Best
  processing temperature 10 to 25°C. Before use, shake the aerosol for 2 minutes and spray a sample.
  Distance to the surface to be treated approximately 25 to 30 centimeter.
- Apply the spray paint in several thin layers. Before applying the next layer, again shake the aerosol. When
  desired, after drying a primer and a lacquer can be applied.
- After use, clean the valve (turn aerosol upside down and press the nozzle for approximately 5 seconds).

### Disposal
