3. Hazards identification

Physical/Chemical

: Highly flammable.

4. First aid measures

General : In all cases of doubt, or when symptoms persist, seek medical attention. If

6. Accidental release measures

7. Handling and storage

Handling

Vapors are heavier than air and may spread along floors. Vapors may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations of vapors in air and avoid vapor concentrations higher than the occupational exposure limits. Avoid contact with skin and eyes. Eating, drinking and smoking should be prohibited in area where this product is handled. Personal Protective Equipment, see section 8. Keep away from incompatibles mentioned in section 10.

Storage
