
2. SAFETY

3. **DIRECTIONS**

- 3.1. Roll to a small crease free cylinder.
- 3.2. Insert as shown.
- 3.3. Hold until expanded.
- 3.4. Ensure suitable fitting.





NOTE: SNR (Signal-to-Noise Ratio) indicates an attenuation value averaged over the relevant frequencies. An SNR value of 34dB for example, in a 100dB noise level environment, reduces it to 66dB.
