### 1. SAFETY

#### 1.2. BATTERY SAFETY

## 2. INTRODUCTION

Powered by lithium-ion technology. Easily fits in a glove box or backpack, weighing at 1.5kg. Multiple high amperage outputs. Fitted with a 115Wh battery. This unit can also supply multiple full charges to batteries in the Sealey 20V, 14V and 12V power tool ranges. Supplies several full charges for smartphones (e.g. iPhone; seven charges and Samsung Galaxy; six charges) or two full charges for your tablet/laptop (based on an 8800mAh battery) as well as many other devices. Fully charges in 8 hours with an 18W fast charger (not included). Supplied with Type-C charging cable. Includes a small integral work light. Inputs: 2 x Bi-Directional Type-C (5V DC 2A, 9V DC 2A,12V DC1.5A). Outputs: 230V~50HZ AC, 2 x 12V 8A DC Outputs (100W MAX.), Standard USB 5V DC 2A, QC3.0 USB (5V DC 2A, 9V DC 2A,12V DC1.5A), 3 x Type-C Outputs (5V DC 2A, 9V DC 2A,12V DC1.5A).

#### 4.1. CHARGING THE POWER PACK

- 4.1.1. Using the TYPE-C Charging cable included, insert the cable in either port (fig 1.7 or 1.8). Connect the other end of the cable into either a USB-A Plug adapter (not supplied), car accessory charger (not supplied) or directly into a wall mounted USB-A output.
- 4.1.2. While charging, the LED charge indicator (fig.1.1), will display battery level. One light lit indicates 0-20%, all five lights lit indicate 80-100%. Once fully charged, the unit will switch off.

## 4.2. USING THE POWER PACK

- 4.2.1. To charge USB digital devices, select appropriate cable for your device. Plug the charging cable into any of the 2 USB-A outputs (Fig 1.3 and fig 1.4) or 3 USB TYPE-C outputs (Fig 1.5, Fig 1.6 or Fig 1.7). Disconnect after use.
- 4.2.2. To use the DC 12V output, plug the car accessory socket cable into the DC output port (fig.1.2) and insert charger (not supplied) into the accessory socket.
- 4.2.3. Disconnect after use.
- 4.2.4. Insert a suitable 3 pin plug into the AC output while ensuring the device is within the recommended wattage.
- 4.2.5. Press and hold the power button (fig.1.9) down for 3 seconds to turn on the AC output.
- 4.2.6. When finished with this feature, press and hold the power button to turn off the AC output.
- 4.2.7. Disconnect after use.

### 4.3. LED WORK LIGHT

- 4.3.1. Double press the power button (fig.1.9) to turn LED on.
- 4.3.2. Press the power button when LED is lit to change between three modes (Normal, SOS and Strobe).
- 4.3.3. Double press the power button to turn the LED off.

### 5. MAINTENANCE

- **5.1.** After usage recharge the unit.
- **5.2.** After charging / usage remove all cables / connections.
- **5.3.** Use a clean, dry cloth to wipe down the unit after use.
- **5.4.** ` Store in clean, dry environment with ambient temperature between 4°C and 30°C.
