### Section 4. First Aid Measures.

4.1 Description of first aid measures

#### Inhalation

Remove casualty from exposure ensuring one's own safety whilst doing so. If breathing becomes bubbly, have the casualty sit Get medical advice / attention.

#### Skin Contact

Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Get medical advice / attention.

4.2. Most important symptoms and effects, both acute and delayedSkin contact: Blistering may occur. Progressive ulceration will occur if treatment is not immediate.Inhalation: There may be shortness of breath with a burning sensation in the throat.

Exposure may cause coughing or wheezing.

Eye contact: Corneal burns may occur. May cause permanent damage.

**Ingestion:** Corrosive burns may appear around the lips. Blood may be vomited. There may be bleeding from the mouth or nose.

**Delayed / immediate effects:** Immediate effects can be expected after short-term exposure.
